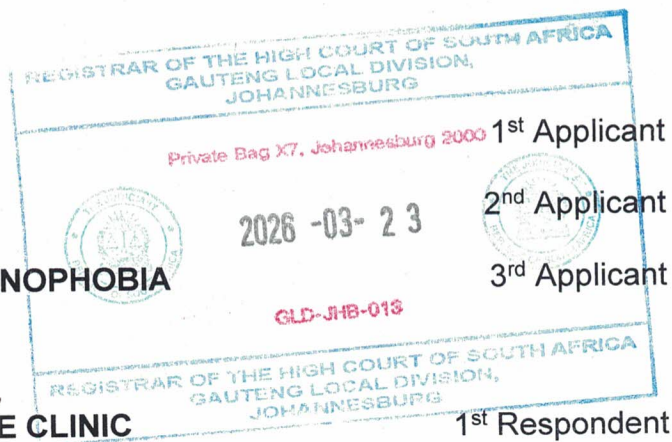

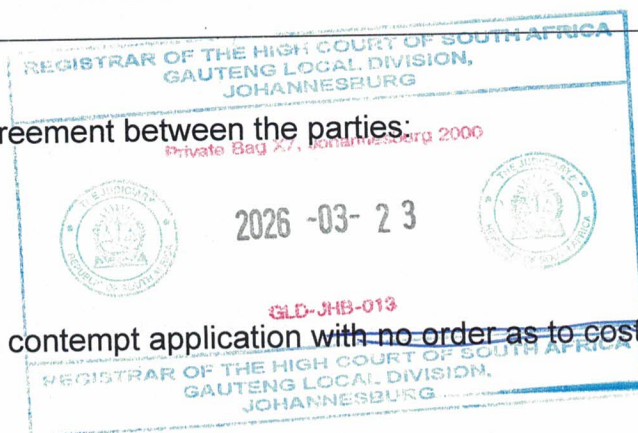
**ORDER**

---

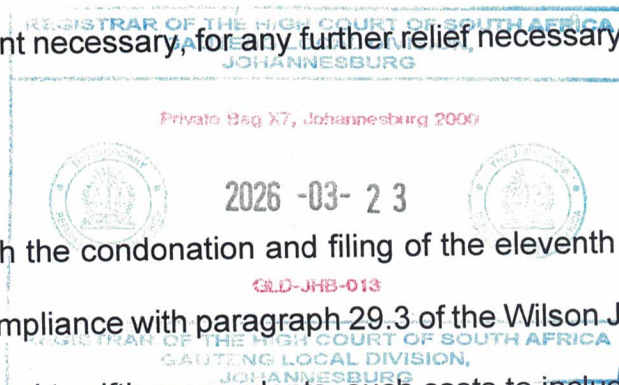
The following order is made by agreement between the parties:

**IT IS ORDERED THAT:**

- 1 The applicants withdraw this contempt application with no order as to cost.
- 2 The first to sixth, seventh to tenth, and eleventh to fifteenth respondents are directed to take reasonable steps to ensure safe and unhindered physical access to the Yeoville and Rosettenville clinics, in compliance with the order in case no **2025/181893**, handed down on 4 December 2025, a copy of which is annexed hereto marked Annexure A ("the Wilson J order").
- 3 The first to sixth, seventh to tenth, and eleventh to fifteenth respondents are directed to furnish the applicants with a report, on affidavit, describing all steps taken to implement that plan, by no later than 18 May 2026.



- 4 The respondents are directed to file Answering Affidavits for purposes of the Part B relief, by no later than 18 May 2026.
- 5 The fourth, fifth, eighth, twelfth, thirteenth and fourteenth respondents are directed to each identify a point person within 10 days of this order who is responsible for facilitating access to the Yeoville and Rosettenville Clinics, and to provide contact details for these point people to the applicants.
- 6 The applicants are granted leave to approach this court on the same papers, duly supplemented to the extent necessary, for any further relief necessary to enforce this order.
- 7 The costs associated with the condonation and filing of the eleventh to fifteenth respondents' report in compliance with paragraph 29.3 of the Wilson J order shall be paid by the eleventh and twelfth respondents, such costs to include the costs consequent upon the employment of two counsel on Scale C.
- 8 The costs of this application are to stand over for determination at the hearing of the Part B application.
